DECLARATION OF BRYTON GORE

I, Bryton Gore, declare as follows:

3 1. The following facts are within my personal knowledge and, if called as a witness
4 herein, I can and will competently testify thereto.

2. Ashley Gore a/k/a Illma Gore is my identical twin sister.

6 3. Until approximately June 2021, I was living in Australia. In 2019 and 2020, I
7 regularly kept in touch with Illma. She told me that she was dating actress Evan Rachel Wood.

4. In or around April 2021, Illma traveled to Australia and stayed with me, my

9 daughters, and my roommate. Illma told me the purpose of her visit was to help me move to the
10 United States in summer 2021. We had discussed me wanting to rejoin our family members who
11 lived in the United States.

12 5. During this trip to Australia, I witnessed Illma using an iPad Pro. Illma told me she
13 borrowed the iPad Pro from our cousin Madeline Dinse (who lived in the United States) because
14 Illma's own iPad had been damaged by Wood's son, Jack. She told me her broken iPad was in the
15 United States.

16 6. In or around April to May 2021, I was sitting next to Illma in the sunroom of my 17 house while she was on a call with Wood over the speakerphone. Illma told me it was Wood on 18 the phone. During this call, Wood said there was "something wrong" with the "FBI letter" and 19 that she needed Illma to send her a copy. This call was tense and Illma appeared unnerved. Illma 20 was using the iPad Pro. I witnessed Illma use the Procreate application (a graphics editing tool I 21 was familiar with) to transfer a signature from one document onto what appeared to be a letter from a federal law enforcement agent. Watching this was alarming so I asked Illma what she was 22 23 doing. She said letter was from the Federal Bureau of Investigation, and it was "OK" because, she 24 said, "I know the agent" and "have her number." When Illma was finished working on the letter, I 25 watched her send it back to Wood.

26 7. In June 2021, my daughters and I moved to the United States from Australia. We
27 first stayed in Oregon with Dinse's mother. In or around July 2021, we moved into a house in
28 Watsonville, California with Dinse.

8. Illma previously told me in about April-May 2021 that she wanted to move in with
 me and Dinse although Illma was living in Los Angeles. In or around July 2021, Illma began
 staying with us in Watsonville, after she told me she had a conflict with her roommate in Los
 Angeles and was moving out. Around this time (August-September 2021) a number of Illma's
 items and furniture were delivered to the house by truck.

6 9. I first saw the broken iPad while Illma was staying with us in Watsonville. Illma
7 gave me the iPad and told me it was a gift for me and my daughters. The screen was cracked and
8 it did not power on. I put the broken iPad away for safe keeping until I could afford to, or figure
9 out how to, fix it. During this time, I observed Illma continuing to use Dinse's iPad Pro.

10 10. In or around September 2021, living with Illma became intolerable. Illma vacated
11 the house, saying that she was going on a work trip to Florida. She did not come back. Illma left
12 behind various items, furniture, and boxes at the house. She took Dinse's iPad Pro with her. She
13 did not take the broken iPad that she gifted to me and my daughters. When Illma left, there was
14 no doubt in my mind that the broken iPad belonged to me.

15 11. In or around October to November 2021, I attempted to get the broken iPad
running. I did not get the screen fixed because it was too expensive. However, I plugged the
broken iPad into a weaker power source (not the wall jack), which I thought may help get it
powered up. It worked, and the broken iPad powered up. Over the years, Illma shared her iCloud
credentials with me so that I could use her account and Apple devices. I opened the iPad with
these credentials once it was powered up so I could use it.

12. What I saw on the broken iPad horrified me. Among other things, I saw emails and
draft emails that were purportedly written and/or sent by me, which I never drafted, authorized, or
sent; and social media posts and draft posts purportedly written by me which I never drafted,
authorized, or posted. I also saw a number of items on the broken iPad relating to Wood, the
Phoenix Act, and Brian Warner p/k/a Marilyn Manson, who I knew was Wood's ex-significant
other.

27 13. One item I saw on the broken iPad was a screenshot of a text conversation on the
28 Signal app between Wood and Illma. A true and correct copy of that screenshot is attached as

1	Exhibit A . The screenshot was dated December 20, 2020. The conversation, dated "Sunday, Nov				
2	22"-November 22 fell on a Sunday in 2020-was between someone named "Alabama," on one				
3	hand, and someone who said that "424-489-1211 is my new number," on the other hand. I know				
4	this is Illma's	phone number because I used the same number to call her. As described further			
5	below, I under	rstand that "Alabama" is Wood because Ilima told me she referred to Wood as			
6	Alabama and I	I witnessed and took part in conversations over the Signal app in which Wood used			
7	the nickname Alabama.				
8	14. In this conversation, Wood stated:				
9		"Here is the letter			
10	To Whom it May Concern:				
11	Please be advised that Ms. Evan Rachel Wood is one of the primary witnesses in connection with an impending criminal				
12	prosecution in Los Angeles involving an international and well known public figure. We have advised Ms. Wood that in our				
13		opinion it is in her and her family's best interest to not be in Los Angeles at the time of this individual's arrest and the criminal			
14		proceedings. The safety of Ms. Wood, her son, Jack as well as the other victims and their families are of utmost concern during this			
15		time.			
16		Whatchu think?"			
17	15.	Illma responded, "It's good[.] I don't know about the letter stating th[e] arrest			
18	before it happ	ens[.]"			
19	16.	Another item I saw on the broken iPad was an image of a undated letter purportedly			
20	written and sig	gned by "Michelle Langer" of the "Federal Violent Crimes Department." A true and			
21	correct copy o	f that screenshot is attached as Exhibit B .			
22	17.	This letter stated:			
23		"To Whom it May Concern,			
24		Please be advised that Ms. Evan Rachel Wood is a key witness in connection to a criminal investigation in Los Angeles, California			
25 26	5 involving an international and well known public figure. The safety of Ms. Wood, her family, other victims, and of their families				
26 27		are of the utmost concern during this time.

1 18. This letter looked very similar to the one I witnessed Illma work on in or around
 2 April to May 2021, when I saw her transfer a signature from one document to another, and send
 3 the finished letter to Wood.

19. 4 Another item I saw on the broken iPad was a image of a document titled "Federal Bureau of Investigation Receipt for Property" dated December 18, 2020. A true and correct copy 5 of that screenshot is attached as **Exhibit C**. At the bottom of the document, next to "Received 6 7 From" is Illma's name and a signature, and next to "Received By" is the name "Elizabeth Farrell" 8 and a signature. This appeared to be the same document—and the same signature for Farrell—that 9 I saw Illma use in or around April to May 2021 to alter the letter she sent to Wood. This image 10 also reminded me of a conversation I had with Illma in approximately December 2020, in which 11 she told me she was investigating Warner; the FBI was involved; the "investigation" was getting 12 "serious"; and, accordingly, she expected to be very busy.

13 20. Another thing I saw on the broken iPad were at least two images of a checklist.
14 One checklist was blank, and others were filled in. A true and correct copy of two such images
15 are attached as <u>Exhibit D</u>.

16 21. Another series of items I saw on the broken iPad were pictures of emails and text
17 messages from Ashley Walters that contained email addresses, social media logins, passwords,
18 addresses, social security numbers, and other personal information about Warner.

19 22. Around this same time, I also looked through the items IIIma had left in the garage
 20 upon leaving for Florida, including unorganized and/or crumpled stacks of papers and other trash.
 21 One item I saw in these discarded materials was a piece of paper covered with what appeared to be
 22 my sister IIIma's handwriting, which I recognized. A true and correct copy of that document is
 23 attached as <u>Exhibit E</u>.

24 23. Another item I saw in these discarded materials was a notebook filled with what
25 appeared to be my sister Illma's handwriting, which I recognized. A true and correct copy of one
26 page from that notebook is attached as <u>Exhibit F</u>.

27 24. In or around early November 2021, I participated in a phone call over the Signal
28 app with Wood, Dinse, and Dinse's mother. We used Dinse's phone. I observed that Wood's

Signal nickname was Alabama. I recognized her voice and she identified herself as Wood. Wood
 wanted to discuss what had happened while Illma was living at our house. According to Wood,
 Gore said I had died three months prior. I said I was not dead.

4	25. The conversation moved to what I saw on the broken iPad and in Illma's discarded			
5	items. I told Wood that I had seen a letter supposedly written about her by an FBI agent, and			
6	earlier that year, I witnessed Illma doctor the same or a similar letter-in other words, that I knew			
7	the letter was a fake. Wood's response shocked me. She said the letter was so important to her			
8	work against Warner, and told me to "think of what would happen" to her and the "victims" if this			
9	ever got out to the media. I offered to send Wood or her attorneys these materials but she			
10	declined.			
11	I declare under penalty of perjury under the laws of the State of California that the			
12	foregoing is true and correct.
