- I am a Defendant in the above-entitled action. I make this declaration in support of my Special Motion to Strike the Complaint. I have personal knowledge of the facts set forth herein, except as to those stated on information and belief and, as to those, I am informed and believe them to be true. If called as a witness, I could and would competently testify to the matters stated herein.
- 2. Exhibit 5 to the Ziemianek Declaration in Support of Special Motion to Strike (filed in this action on May 24, 2022) is a transcript of the Marilyn Manson *Dinner for Five* interview that I reviewed in 2016 or 2017 and discussed in my deposition. Exhibit 6 to the Ziemianek Declaration is another online article I reviewed at or about the same time, which includes similar statements from Warner concerning why *Groupie* was never released. As I stated in my deposition, I relied on Warner's statements cited in these materials in forming my belief that *Groupie* depicted illegal content.
- 3. Exhibit 8 to the Ziemianek Declaration is an article I read in or about 2019, and is among the articles I mentioned in my deposition.
- 4. I never pressured, recruited, or coerced anyone to make false accusations against Warner.
